WITNESSETH

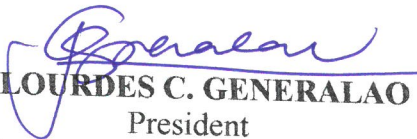
NOW THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:

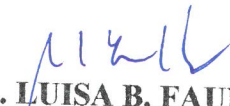
