BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 2018-06

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the **Repair & Rehabilitation of University Gymnasium & Cultural Center, USEP Obrero Campus, Davao City** with a budget allocation of **Seven Million Seven Hundred Twenty-Nine Thousand Three Hundred Seventy-Seven & 20/100 Pesos (P 7,729,377.20)**, and posted the same in PhilGePS on March 15-22, 2018 and in conspicuous places like USEP Main Gate Bulletin Board on the same period;

WHEREAS, in response to the said advertisements, there are (4) bidders submitted letter of intent including application for eligibility to the Bids and Awards Committee (BAC namely: Edison Development & Construction, Megila Const. Dev't & Supply, Leamor Const. & Supply, ASM Francisco Const. & Dev't Corp.;

WHEREAS, the (4) bidders were received and opened by the BAC on April 11, 2018;

WHEREAS, the detailed evaluation of the submitted bid resulted in the following:

WHEREAS, during the bid evaluation the BAC observed that the single largest completed contract (SLCC) which is similar in nature to the ongoing bidding was completed 20 March 1998, which is 20 years ago, and not within the last three (3) years (2014-2017) as required by the University;

WHEREAS, the detailed bid evaluation and validation of the specifications was conducted by the TWG, while the bid evaluation was carried out by the BAC on April 18, 2018 that resulted in the following:

WHEREAS, during the opening of bids on 11 April 2018, your bid was declared as the second lowest bid as read. After the bid evaluation, it was still determined as the second lowest calculated bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted to the BAC by the bidder with the Lowest Calculated Bid (LCB), the said bidder, Megila Const. Dev't & Supply passed the post qualification process, and, is therefore determined as the Bidder with the Lowest Calculated Responsive Bid (LCRB).


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:


a.) To declare Megila Const. Dev't & Supply as the Bidder with the Lowest Calculated and Responsive Bid for the Repair & Rehabilitation of University Gymnasium & Cultural Center, USEP Obrero Campus, Davao City.


b.) To recommend for approval by the Head of Procuring Entity the foregoing findings.


