## **BAC Resolution Declaring LCRB and Recommending Approval**

## **RESOLUTION NO. 2018-06**

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the Construction of 5-Storey Information Technology (IT) building Phase IV, USeP Obrero Campus, Davao City with a budget allocation of Nine Million Six Hundred Eighty-Seven Thousand Two Hundred Thirty-Two & 03/100 Pesos (P 9,687,232.03), and posted the same in PhilGePS on March 15-22, 2018 and in conspicuous places like USeP Main Gate Bulletin Board on the same period;

WHEREAS, in response to the said advertisements, four (4) bidders, namely: Edison Development & Construction; Hexamindz Corporation; ASM Francisco Const. & Dev't Corp.; and Leamor Const. & Supply, submitted letter of intent including application for eligibility to the Bids and Awards Committee (BAC);

WHEREAS, the bids of the four (4) bidders were received and opened by the BAC on April 11, 2018;
