WHEREAS, in response to the said advertisements, only one (1) bidder Unicenter Communication submitted letter of intent including application for eligibility to the Bids and Awards Committee (BAC;

WHEREAS, only one (1) bid was received and opened by the BAC on April 11, 2018;
