BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 2017- 19

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the **Establishment of Industrial Electronics and Mechatronics Training Center Phase IV** with a budget allocation of **Twenty Seven Million Two Hundred Seventy Seven Thousand Seven Hundred Sixty Seven & 71/100(PhP 27,277,767.71) Pesos**, and posted the same in PhilGePS on August 26, 2017 to September 04, 2107 and conspicuous places namely: USEP Main Gate Bulletin Board and USEP Websites, on the same period;

WHEREAS, in response to the said advertisements, three (3) Contractors/Bidders submitted letter of intent and purchased bidding documents namely Riezl Landcare & Construction , Astrobuilt Construction & Development and Micah Construction and Supply .

WHEREAS three (3) bids were submitted and **received by the BAC on September 25, 2017, 2017**

WHEREAS during the opening of bids one of the bidders, which is **Astrobuilt Construction and Development failed to submit duly signed financial bid form, declaring it disqualified;**

WHEREAS, the detailed evaluation of the submitted bid resulted in the following:
