BAC Resolution Declaring LCRB and Recommending Approval

BY

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the **Construction of University Security System (Gate 1, 2, &3)** with a budget allocation of **One Million Two Hundred Seven Thousand Three Hundred Sixty Three Pesos & 82/100 (PhP. 1,207,363.82)**, and posted the same in PhilGEPS on December 11, 2017 to December 17, 2017 and in conspicuous places of the University like USEP Main Gate Bulletin Board, and on the USEP Website, on the same period;

WHEREAS, in response to the said advertisements, **only one (1) Contractor/Bidder** submitted to the Bids and Awards Committee (BAC), letter of intent including application for eligibility and Amazing Find Builders Corporation was found eligible and purchased bidding documents;

WHEREAS, only one (1) bid was submitted and received by the **BAC on January 5, 2018**;

WHEREAS, the detailed evaluation and validation of the specifications was conducted by the Technical Working Group (TWG), while the bid evaluation was carried out by the BAC on February 2, 2018 that yielded the following details:

WHEREAS, upon post-qualification on February 2, 2018 or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted to the BAC by the bidder with the Lowest Calculated Bid (LCB), the said bidder, **Amazing Find Builders Corporation** passed the post qualification, and, therefore, was determined as the Lowest Calculated and Responsive Bid (LCRB) considered for award of the contract.

Section 36. Single Calculated/Rated and Responsive Bid Submission. *A single calculated/rated and responsive shall be considered for award if it falls under of the following circumstances.*

- a. *If after advertisement, only one prospective bidder submits a letter of intent/or applies for eligibility check, and meets the eligibility requirements or criteria, after which it submits a bid, which is found to be responsive to the bidding requirements.*
