BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the Construction of 5-Storey College of Engineering Laboratory Building Phase 1B with a budget allocation of Two Million Four Hundred Eighty Six Thousand Eight Hundred Ninety Four Pesos and 06/100 (PhP 2,486,894.06), and posted the same in PhilGePS on December 8-14, 2017 and in conspicuous place like USeP Main Gate Bulletin Board and USeP Websites, on the same period;

WHEREAS, in response to the said advertisements, two (2) Contractors /Bidders submitted letter of intent and purchased bidding documents namely Amazing Find Builders Construction and ASM Francisco:

WHEREAS, the opening of bids was held on December 28, 2017;

WHEREAS during the preliminary scrutiny of the bidding documents, ASM Francisco was found to be non-complying for submitting expired tax clearance;
