BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 2018-15

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the Construction of Administrative Building Phase I, USeP Obrero Campus, Davao City with a budget allocation of Ninety-Six Million Five Hundred Eighty-Eight Thousand One Hundred Twenty-Eight & 08/100 Pesos (P 96,588,128.08), and posted the same in PhilGePS on July 12 to 19, 2018 and in conspicuous places like USeP Main Gate Bulletin Board on the same period;

WHEREAS, in response to the said advertisements, three (3) bidders, namely: BRIMA Construction & Enterprises; AVECs Corporation; Verzontal Builders, Inc., submitted letter of intent including application for eligibility to the Bids and Awards Committee (BAC);

WHEREAS, the bids of the three (3) bidders were received and opened by the BAC on August 02, 2018;

WHEREAS, during the opening of bid two (2) bidders namely; AVECs Corporation; Verzontal Builders, Inc., submitted expired PCAB license, hence the BAC declared their technical/eligibility requirements as non-complying;

WHEREAS, the Bids and Awards Committee underscored during the Pre-Bid and Opening of Bids Non-Policy Matters (NPM) No. 2016-104 dated December 06, 2018, issued by the Government Procurement Policy Board, which states that "A) PCAB license as an eligibility requirement for the procurement of infrastructure projects under Section 23.1 (a) (iv) of the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) should be valid at the time of the deadline for submission and opening of bids. In the case at hand, the bidders should have submitted a PCAB license that is valid as of the date of the deadline for submission of bids and opening of bid."

WHEREAS, the bid of BRIMA Construction & Enterprises complied both technical and financial documents;
