**BAC Resolution Declaring Single Calculated & Responsive Bidder (SCRB) and
 Recommending Award of Contract**

RESOLUTION NO. 2020-05

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the **Procurement of Clerical Services (41 Clerks) for FY 2020-2021 of USeP-Obrero & Mintal Campuses**, with a budget allocation of **Six Million Four Hundred Ninety-Five Thousand One Hundred Sixty-One & 29/100 Pesos (PhP 6,495,161.29)**. The University posted the same in the PhilGePS on 06 September to 10 October 2020, on the University website, and in conspicuous places like USeP Main Gate's Bulletin Board on the same period;

WHEREAS, on 25 September 2020, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by lone prospective bidder, LSERV Corporation;

WHEREAS, on 09 October 2020, the scheduled opening of bids, the abovementioned prospective bidder submitted its bid proposal and passed the preliminary examination of bids;

WHEREAS, in response to the said advertisement, only one (1) bidder, namely LSERV Corporation, submitted their letter of intent including their application for eligibility to the Bids and Awards Committee (BAC);

WHEREAS, the bid proposal of the lone eligible bidder was found to be substantially complying:




