

CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT, made this ___ day of ___ 20___, by and between:

The **University of Southeastern Philippines**, with office address at Bo. Obrero Davao City, represented by its President, **Dr. Lourdes C. Generalao** hereinafter called the "ENTITY",

-AND-

The **LIBTECH SOURCE PHILIPPINES INC.** with office address located at Medalle bldg., Fuentes Osmena Capitol Site. Cebu City Cebu, Region VII, Philippines, represented by its Finance & Administrative Manager, **MS. AMY P. SABLAON**, hereinafter called the "SUPPLIER".

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of Educational E-Resources for ULRC of USEP, Obrero Campus, Davao City**, has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Eight Hundred Thirty Thousand One Hundred Twenty-Five Pesos (Php 1,830,125 .00)**, herein after called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this AGREEMENT, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Riles and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this AGREEMENT, viz:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or
 - vi. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of One Million Eight Hundred Thirty Thousand One Hundred Twenty-Five Pesos (Php 1,830,125 .00), or such other sums as may be ascertained, **LIBTECH SOURCE PHILIPPINES INC.** agrees to deliver on the Procurement of Educational E-Resources for ULRC of USEP, Obrero Campus, Davao City in accordance with its Bid.
4. The Supplier shall deliver and install to the Entity the goods mentioned in the project: **Procurement of Educational E-Resources for ULRC of USEP, Obrero Campus, Davao City** within 45 calendar days.




