**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT
 OF CATERING SERVICES FOR ACT for AMIA
 (MOA Signing, Baseline Data Gathering & Ground Breaking Ceremony)**

Whereas, the ACT for AMIA is an extension service project of the College of Development Management with funding support from the Department of Agriculture for the implementation of climate smart agriculture in the partner barangays of Suawan, Tamugan, and Magsaysay in Marilog District, Davao City;

Whereas, the said project has requested for the procurement of catering services for the February 29, 2020 MOA signing and baseline data gathering with project partners as well as for the ground breaking ceremony for the construction of a farm house in the model farm site as per purchase request number PR # 20-02-023 dated February 4, 2020 and PhilGEPS Reference Number 6837136 dated February 5, 2020, with a total approved budget for the contract (ABC) amounting to One Hundred and Six Thousand (P106,000.00) pesos for meals and snacks of 265 participants chargeable to Fund 164-ACT for AMIA;

Whereas, during the February 11, 2020 opening of bids by the Bids and Awards Committee, four suppliers submitted to their bid documents, namely **Davao Episcopal Multipurpose Cooperative, Mommy Julie Meals and Grills, Hazeline Catering Services, and Davao Eagle Ridge Resort** with the following price quotations as summarized in the table below:

Resolved finally that a copy of this BAC resolution shall be furnished to the College Dean /Head of Procuring Entity for his information and approval.


