BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 2020-03

WHEREAS, the University of Southeastern Philippines advertised the Invitation to Bid for the **Procurement of Air-conditioning Unit with Installation for RDE Building at USEP Mabini Campus**, with a budget allocation of Two Million Pesos (PhP. 2,000,000.00) and posted the same in the PhilGePS on August 26 to September 16, 2020, on the University website, and in conspicuous places like USEP Main Gate Bulletin Board on the same period.

WHEREAS, on September 02, 2020, the Bids and Awards Committee (BAC) held the pre-bid conference which were attended by five (5) prospective bidders, namely: Oliv-Air Airconditioning Services, CDO Air Concept, Daikin Davao, EMCOR Bajada Davao and RC BAR Builders;

WHEREAS, two (2) bidders, namely: Oliv-Air Airconditioning Services and RC Bar Builder purchased bidding documents and on September 23, 2020, the scheduled opening of bids, the two bidders submitted their respective bid proposals;

WHEREAS, during the opening of bid, Oliv-Air Airconditioning Services passed the preliminary examination of bids while *RC Bar Builders failed due to non-compliance on the Statement of Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of this IRR;*

WHEREAS, upon careful evaluation of the TWG and BAC members of the bid proposal of Oliv-Air Airconditioning Services on October 05, 2020, its bid was found substantially complying;

WHEREAS, on October 08, 2020, the BAC sent letter to Oliv-Air Airconditioning Services, informing the latter that the bid evaluation has resulted to bid amount as calculated amounting to **Two Million Fifty-Three Thousand Eight Hundred Five Pesos (₱2,053,805.00);**

WHEREAS, the BAC sought the confirmation of the bidder for willingness to still deliver the following items at a bid amount of **₱ 1,943,340.00 (bid amount as read):**

- a) 2HP Wall-mounted inverter air-conditioning units, with installation (6 units)
- b) 2.5HP Wall-mounted inverter air-conditioning units, with installation (11 units)
- c) 3 tons/4HP Floor-mounted inverter air-conditioning units, with installation (7 units)

NOW THEREFORE, We the Members of the Bids and Awards Committee hereby **RESOLVE**, as it is hereby **RESOLVED**:


1. To declare **Oliv-Air Airconditioning Services**, as the Bidder with **Lowest Calculated and Responsive Bid (LCRB)** for the **Procurement of Air-conditioning Unit with Installation for RDE Building at USEP Mabini Campus**;
2. To recommend to the Head of Procuring Entity, for approval, the award of the said contract to **Oliv-Air Airconditioning Services** at its total bid of **One Million Nine Hundred Forty-Three Thousand Three Hundred Forty Pesos (Php 1,943,340.00)**.
