WHEREAS, on 10 December, 2018, a Pre-Bid meeting was held and attended to by RSP Enterprises Incorporated, ASM Francisco Construction and Amazing Find Builders;

WHEREAS, during the opening of bid on 11 January, 2019, three (3) bidders namely: ASM Francisco Constructions, LV Ledesma Construction, Inc. and Angel & Sam Construction & General Merchandise submitted letter of intent and purchased the bidding documents:

WHEREAS during the bid evaluation and post qualification process, it was determined that the first two bidders were declared failure/Non-complying due to the following reasons, to wit:

1. L.V Ledesma Construction, Incorporated (ranked 1st)

Submitted erroneous computation of Net Financial Contracting Capacity (NFCC). When the NFCC was corrected, it resulted to an amount lower than the ABC.

2. Angel & Sam Construction & General Merchandise (ranked 2nd)

The submitted Single Largest Completed Contract (SLCC) below 50% of the ABC. Contrary to Section 23.4.1.3 of IRR in RA 9184. "The prospective bidder must have completed, within the period specified in the Invitation to Bid, an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC xxxxx "

WHEREAS, respective Notices of Post-Disqualification were sent by the BAC to LV Ledesma, and Angel and Sam; LV Ledesma submitted a Motion for Reconsideration, however, it was still denied by the BAC. Angel and Sam did not submit a Motion for Reconsideration:
