## **RESOLUTION NO. 10-2019**

A RESOLUTION DECLARING THE LOWEST AND MOST RESPONSIVE BID
AND RECOMMENDING APPROVAL FOR THE AWARD OF THE
EXPANSION/REHABILITATION OF COVERED COURT IN MINTAL CAMPUS

**WHEREAS**, the USeP- Mintal Campus had issued a request for quotation and advertised the invitation to bid for the expansion/rehabilitation of covered court in Mintal Campus as per purchase request number PR # 2019-07-0624 dated July 21, 2019 with a total approved budget for the contract (ABC) amounting to Nineteen Million, Three Hundred Three Thousand Five Hundred Forty Five pesos and Twenty Eight Centavos (19,323,545.28);

WHEREAS, in response to the said request for quotation and posting at the CDM BAC Bulletin Board, four suppliers, namely, ASM Francisco Construction & Development Corp., RC BAR Builders, BRIMA Construction and Enterprises and Minkonstrak Engineering and General Services have returned/submitted their bid documents.

WHEREAS, in reference to the BAC Resolution No. 09-2019, the latter (Minkonstrak Engineering and General Services) was disqualified after the deliberation of the BAC members with the presence of the COA Auditor, since the said bidder had (1) submitted an expired official registration of truck vehicle (# 3.c :List of Contractor's major equipment), (2) failed to declare the item # 9 of the Omnibus Sworn Statement and (3) the Audited Financial Statements, which were not stamped "Received" by the BIR (# 8 Class "A" Financial Document).

**WHEREAS**, the submitted bid quotation documents opened by the USEP- Mintal Campus Bids and Awards Committee at the USEP Mintal Accreditation Office on July 24, 2019, are summarized in the table below:
