**Invitation to Bid for *the Conversion of Speech Laboratory Classroom to Agri-Industrial Research Laboratory – Tagum City***  
***PB Infra – 2020-005***

1. The *University of Southeastern Philippines Tagum-Mabini Campus*, through the *GOP-Fund 164*<sup>1</sup> intends to apply the sum of *One Million Three Hundred Eighty One Thousand Nine Hundred Twenty One Pesos & 10/100 only (Php1,381,921.10)* being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *University of Southeastern Philippines Tagum-Mabini Campus* now invites bids for *the Conversion of Speech Laboratory Classroom to Agr-Industrial Research Laboratory – Tagum City*.<sup>2</sup> Completion of the Works is required within *120 Calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *the BAC Office, USEP Tagum-Mabini Campus, Tagum City* and inspect the Bidding Documents at the address given below from *8:00 a.m – 5:00 p.m.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *Feb.5-19, 2020* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *University of Southeastern Philippines* will hold a Pre-Bid Conference<sup>3</sup> on *February 7, 2020 @ 1:30 p.m* at *USEP BAC Office, Tagum City*, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *February 20, 2020 @ 9:00 a.m.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *February 20, 2020 @ 9:30 a.m* at *BAC Office, USEP Tagum City.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
