**WHEREAS**, in response to the said advertisements, two (2) Contractors/Bidders submitted letter of intent and purchased bidding documents namely, **Hexamindz Corporation** and **Golden Vido Builder and Supply**;

**WHEREAS**, the opening of bids was held on **November 20, 2017**;
