**Invitation to Bid for the
Construction of Cedu Layer Poultry Production
PB Infra – 2020-017**

1. The *University of Southeastern Philippines Tagum-Mabini Campus*, through the *GOP-Fund 164¹* intends to apply the sum of *Four Million Three Hundred Seventy One Thousand Nine Hundred Eighty Pesos & 68/100 only (Php4,371,980.68)* being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *University of Southeastern Philippines Tagum-Mabini Campus* now invites bids for *the Construction of Cedu Layer Poultry Production*. Completion of the Works is required within *160 Calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *the BAC Office, USEP Tagum-Mabini Campus, Tagum City* and inspect the Bidding Documents at the address given below from *8:00 a.m – 5:00 p.m.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *September 7-18, 2020* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *University of Southeastern Philippines* will hold a Pre-Bid Conference² on *September 7, 2020 @ 1:30 p.m* at *USEP BAC Office, Tagum City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *September 21, 2020 @ 9:00 a.m.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *September 21, 2020 @ 9:30 a.m* at *BAC Office, USEP Tagum City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


